List each item you wish to speak on individually.*** Each citizen will be allowed a ***maximum of three (3) minutes*** to speak. Public Comment period will last no longer than a total of fifteen (15) minutes. After the designated public comment time, no further comment from the public will be acknowledged or accepted. There will be no discussion of the items brought forth in public comment time from the mayor or city council members. Also, there will be no discussion among citizens at the meeting. At the discretion of the mayor, comments presented during public comment time could possibly be considered as an agenda item in upcoming city council meetings.

4) Discuss and take action on a policy or ordinance concerning culverts and ditches.
