Notice is hereby given that a meeting of the City Council of Milano will be held Monday, September 15, 2025 at 6:30pm, Milano Civic Center, 120 West Avenue E to consider items as follows. The listed items are subject to action.

1) CALL TO ORDER

2) PUBLIC COMMENTS

An opportunity for the public to make comments or address concerns not posted on the agenda. The City Council will take no action during this portion of the agenda. The Council may only ask clarifying questions or direct staff to take appropriate action. Individuals wishing to speak will sign in by completing a Public Comment Form and present it to the mayor **prior to the start of the meeting. List each item you wish to speak on individually.** Each citizen will be allowed a **maximum of three (3) minutes** to speak. Public comment period will last no longer than a total of fifteen (15) minutes. After the designated public comment time, no further comment from the public will be acknowledged or accepted. There will be no discussion of the items brought forth in public comment time from the mayor or city council members. Also, there will be no discussion among citizens at the meeting. At the discretion of the mayor, comments presented during public comment time could possibly be considered as an agenda item in an upcoming city council meeting.

3) CONSENT AGENDA

- b. Approve the September 2025 financial report and pay the bills for the City of Milano.

4) Discuss and take action - Grant GLO #22-085-060-D317, mayor sign updated financial policies to include: (1) City of Milano Labor Standards Review Policy for Federal and State Grants; (2) City of Milano Financial and Procedures; (3) City of Milano Procurement Policies and Procedures for Federal Grants, after city council approval.

5) Tomm Owens – Request to continue discussion about plans for old bank building that is currently owned by the city.

6) Discuss and take action – Opening money market account and purchase a certificate of deposit at Edward Jones in the Cameron, Texas office.

7) Discuss and take action – Confirm date for Christmas Parade and Community Wide Christmas Dinner.
