2) PUBLIC COMMENTS

Individuals wishing to speak will sign in by completing a Public Comment Form and present it to the mayor prior to the start of the meeting. List each item you wish to speak on individually. Each citizen will be allowed a maximum of three (3) minutes to speak. Public comment period will last no longer than a total of fifteen (15) minutes. After the designated public comment time, no further comment from the public will be acknowledged or accepted. There will be no discussion of the items brought forth in public comment time from the mayor or city council members. Also, there will be no discussion among citizens at the meeting. At the discretion of the mayor, comments presented during public comment time could possibly be considered as an agenda item in an upcoming city council meeting.

- b. Approve the October 2025 financial report and pay the bills for the City of Milano.
